## TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED) THE TRUSTEES OF THE BRITISH MUSEUM BRITISH MUSEUM, GREAT RUSSELL STREET, LONDON, WC1B 3DG DISCHARGE OF CONDITION 15 PURSUANT TO PLANNING PERMISSION REF: 2023/1848/P

On behalf of our client, The Trustees of the British Museum, please find enclosed an application for the discharge of condition 15 (Green Roof Details) of the Planning Permission, dated 17 July 2024. Permission was granted for:

"Erection of new two storey building, plus basement and associated works to provide plant and welfare accommodation ancillary to the Museum following demolition of existing building and two storey structures on East Road (to the rear of 9-11 Montague Street and 43 Russell Square)."

Condition 15 requires that:

"Prior to above ground works (excluding demolition down to ground level) full details in respect of the living roof in the area indicated on the approved roof plan shall be submitted to and approved by the local planning authority.

The details shall include:

i. a detailed scheme of maintenance

*ii.* sections at a scale of 1:20 with manufacturers details demonstrating the construction and materials used *iii.* full details of planting species and density

The living roofs shall be fully provided in accordance with the approved details prior to first occupation and thereafter retained and maintained in accordance with the approved scheme"

Note it is proposed to plant the green roof with the Bauder Seed Mix 3 as indicated on the drawings / and specification sheet. The details of seed mix 3 are included in the flora Seed mix Technical Data Sheet.

We are therefore of the view that the enclosures sufficiently cover the points 1 to 3 of condition 3 and that the details can therefore be approved.
