T1: Twin-stemmed Birch: Approximately 7.00m: Remove dead wood throughout crown. Tip prune to reduce by 0.50m-1.00m. General maintenance.	
T2: Centre Birch: Approximately 6.00m: Tip prune to reduce by 1.20m. General maintenance.	

T3: Right hand Birch: Approximately 6.00m: Reduce back to previous and most recent reduction points whilst preserving ample fine branch structure approximately 1.00m-1.50m. Thin crown density throughout by approximately 20%. Remove dead wood. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
