NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Bay (T1) - Reduce live branches by up to 1m - 2m length. Trim top and sides of canopy by 1m - 2m to maintain size and shape.

1 x Pittosporum (T2) - Reduce over-extended branches by up to 1m - 1.5m length growing towards and over neighbour's roof.

1 x Magnolia (T3) - Reduce live branches by up to 1m - 2m length in canopy centre. Reduce live, over-extended branches by up to 0.2m - 0.5m length in lower canopy.

1 x Laburnum (T4) - Reduce all live branches by up to 0.5m - 1m length in entire canopy.

1 x Crab-apple (T5) - Reduce all live branches by up to 1m - 2m length and prune sides to balance form.

1 x Juniper (T6) - Reduce over-extended branches over path by up to 1m.

1 x Pear (T7) - Remove diseased branches.

1 x Elderberry (T8) - Reduce all live branches by up to 1.5m - 2m length in entire canopy

The Council has considered your notification of intended works to trees dated 06 August 2024 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is

completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
