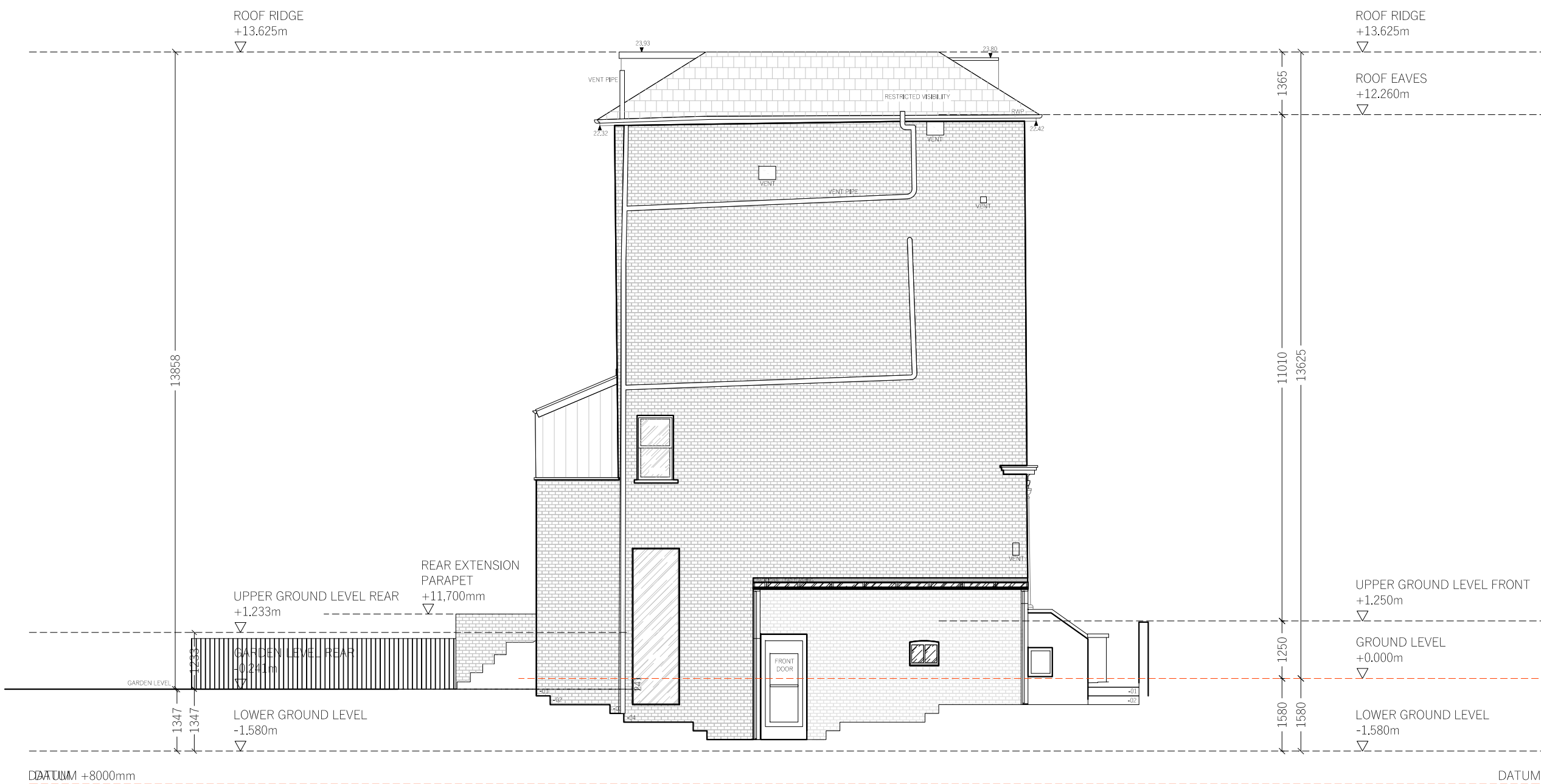

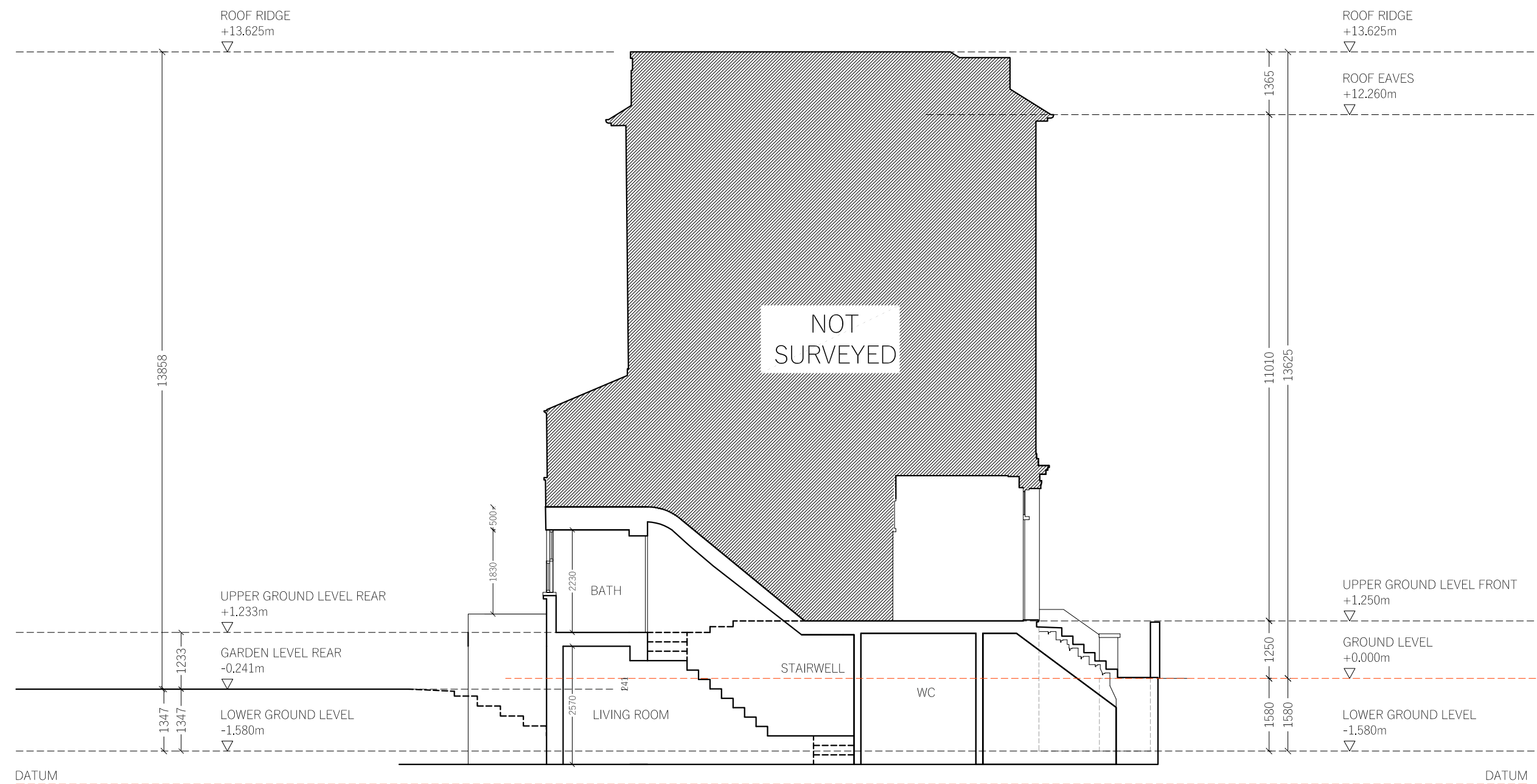
EXISTING NORTH WEST (FRONT) ELEVATION

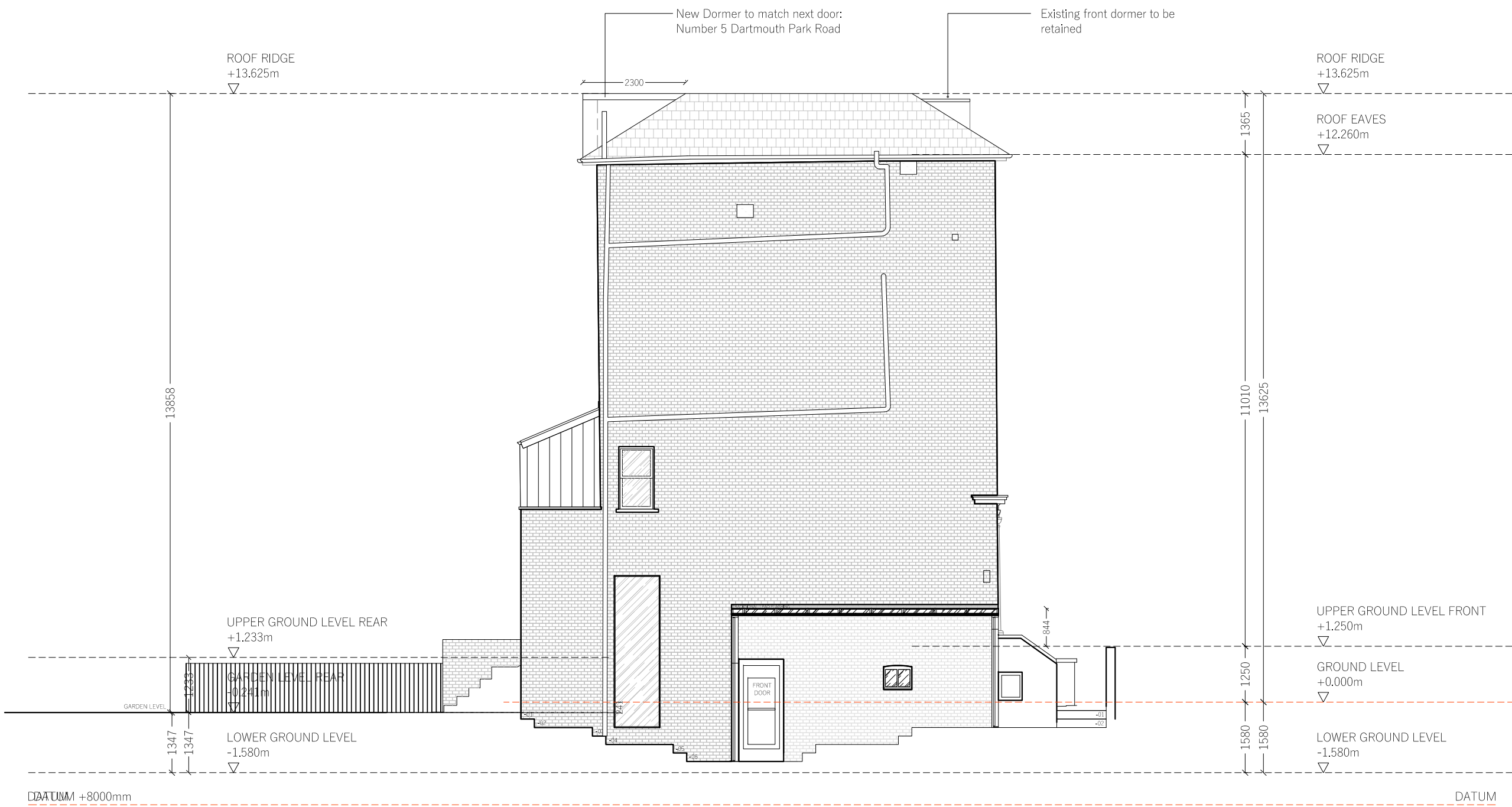




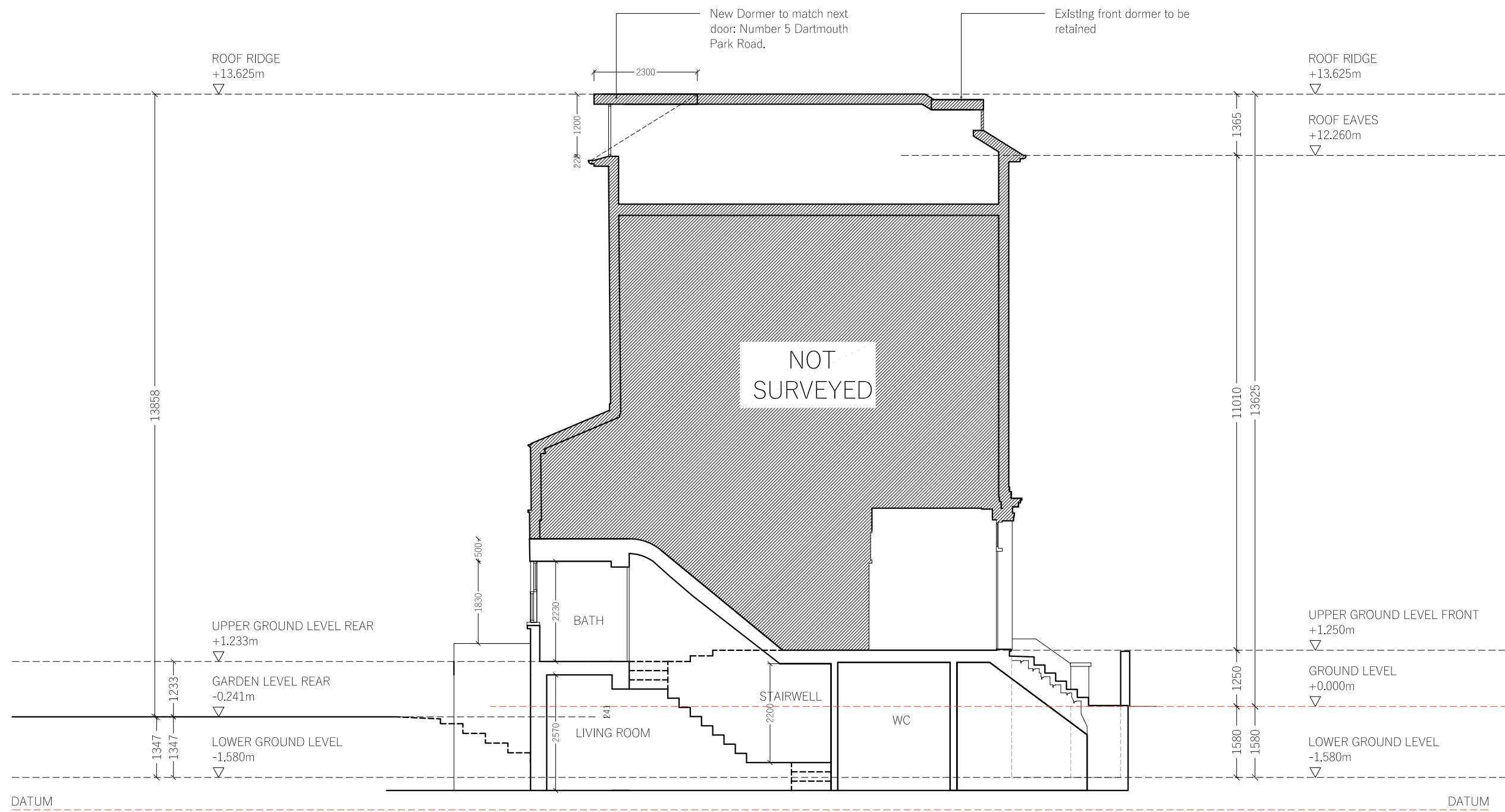
PROPOSED NORTH WEST (FRONT) ELEVATION

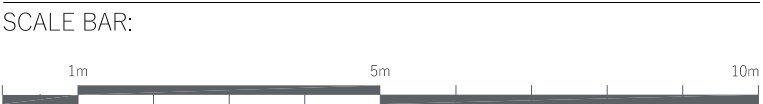
