Front Garden:

T1: Mature Pittosporum: Approximately 7.00m: Overhanging from Follie House, East Heath Road: Reduce height by approximately 1.20m. Reduce lateral and sub lateral growth, growing towards No.15 by up to 1.00m. To control encroachment.

Rear Garden:

- T2: Mature Magnolia: Approximately 7.00m: Reduce crown height by approximately 0.550m-1.00m. Remove dead wood throughout crown. General maintenance.
- T3: Small Acer: Approximately 4.00m: Thin upper crown density by 30%. Reduce upper crown by up to 0.50m. General maintenance. Rear Boundary:
- T4 & T5: 2 x Irish Yews: Approximately 5.00m: Lightly trim tops by up yo 30cm to formalise. General maintenance.
- T6: Birch: Approximately 10.00m: Reduce rear of crown overhanging property by approximately 1.20m. Thin upper crown density by approximately 105-15%. Remove dead wood.
- T7: Mature Birch: Approximately 11.50m (Nearest House): Tip prune to ensure clearance of crown of T6, approximately 0.30m-0.50m. Thin upper crown density by 10%. Tip prune back from building approximately 0.30m-0.50m. Remove dead wood. Control encroachment.
- G1: Group of Mature Magnolia Grandiflora: 7.00m: Reduce height of the tree/hedge line by up to 1.20m. Reduce lateral and sub lateral branches overhanging the rear boundary back to as near to the boundary as practicable by up to 1.20m. Reduce overlong lateral and sub lateral growth overhanging the lawn back into the main hedge structure up to 0.50m. To control encroachment.
- T8: Large Bay: Approximately 5.00m: Reduce height back to previous points of reduction, approximately 1.20m of regrowth. Reduce lateral and sub lateral growth to help reshape up to 1.00m. To control encroachment.
- T9: Smaller Bay: Approximately 3.00m: Trim back to tidy and control encroachment, reducing back over neighbouring property to clear, up to 0.50m reduction.
- T10: Mature Cherry: Approximately 16.00m: Remove dead wood throughout crown. Thin crown density by 15%, concentrating on the area of the crown overhanging the Mulberry tree beneath. Reduce lateral and sub lateral branches overhanging Mulberry and growing towards the bay tree adjacent by approximately 1.20m. Control encroachment.
- Ivy: Trim back ivy that is growing into neighbouring garden to control encroachment.
- G2: Photinia: Approximately 3.00m: Tip prune by approximately 30cm to tidy. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- · Tree species
- · The number used on the sketch plan; and
- · A description of the proposed works.

Where trees are protected by a Tree Preservation Order you must also provide:

- · Reasons for the work; and where trees are being felled
- · Proposals for planting replacement trees (including quantity, species, position and size) or reasons for not wanting to replant.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

## Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - $\circ~$  mark and name surrounding roads  $\,$
  - $\circ\,$  sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ~$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
