Proposal :

The erection of a roof extension for financial & professional services use (A2).  
As shown on drawing Nos 999/101/02, 03, 04 and 05.

The Council has considered your application and decided to refuse permission for the following reason(s):

Reasons for Refusal

- 1 The proposed roof extension would be overly dominant and would disrupt the largely unaltered rooflines in the terrace to the detriment of the appearance of the property. The detailed design of the proposed roof extension does not complement the architecture of the existing property and is contrary to Supplementary Planning Guidance. The proposal would therefore be contrary to policies EN16 (new) and EN57 of the Camden Unitary Development Plan Adopted March 2000.
