Reduce magnolia (T1) by up to 1.5m to get clearance from building, reduce back to boundary on neighbour's side. Tree is in the front garden of no 29.
Remove lowest two branches on plum (T2) growing over garden. Tree is in back garden on no 29.

Reduce magnolia (T3) branches overhanging garden at no. 29 by 2m. Tree is in back garden of no 31, owner is unknown.

Reason: To allow more light into both gardens and create clearance from building.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
