We have plans to cut the branches back due to safety concerns as the branches are currently hanging over onto Sidmouth Street. It is a large London Plane; the plan would be to cut back 4m and lift; and the other is an ash tree to be cut back by 3m which is also overhanging the road. This was advised by our tree surgeon.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
