### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

IN COMMUNAL GARDENS: 1 x Pissard's Plum (*Prunus cerasifera* 'Pissardii') (T240) RVL - Remove heavily declining limb to the east at 2.5m back to live upright mature epicormic stem 1.5m out from the main stem union.

1 x Apple (*Malus* sp.) (T244) - Remove all declining lower limbs and shoots to facilitate more detailed monitoring of crown health.

1 x London Plane (*Platanus x hispanica*) (T268) - Prune from adjacent structure to clear lamp column by 1.5m and also lightly tip prune low hanging branches to the east overhanging and encroaching upon the driveway to maintain a clearance of 4m.

The Council has considered your notification of intended works to trees dated 28 August 2024 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
