Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Eucalyptus - we would like to fell to ground level. The tree is situated in the rear garden of 10 Gloucester Crescent, a listed property. The tree is exerting pressure on the rear boundary wall, which has resulted in the formation of cracks. Given its limited amenity value and potential for

further damage, it is recommended that the tree be removed and stump treatment with eco-plugs to prevent disturbance to the wall's foundations. A replacement tree of an appropriate species can be provided upon request.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
