REFERENCE 10. CONCLUSION: THE REAR EXTENSION WAS CONSIDERED ACCEPTABLE IN PRINCIPLE; HOWEVER, IT WAS ENCOURAGED TO REDUCE THE GLAZING TO THE SIDE ELEVATION.
