T1: Holly: Approximately 5.00m-6.00m: Reduce height by approximately 30% (2.20m.) Reduce lateral and sub lateral growth by approximately 1.20m. General maintenance.

T2: Mature Cherry: Approximately 9.00m-10.00m: Reduce crown by approximately 1.20m-1.50m ensuring preservation of branch structure. Thin crown density by approximately 20%. Remove dead wood throughout crown. To increase light levels to both No.3 & No.5./General maintenance.

T3: Leyland Cypress: Approximately 6.00m: Reduce lateral and sub lateral branches by approximately 1.00m (preserve screen along rear of No.5). General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
