DD 5 Day Notice (TPO REF. C1293 2023) IN PARK: 2 x Golden Rain Trees (T48 & T49) - Fell to ground level.

Thank you for your letter/telephone call of 04 July 2024 giving notice that the above tree(s) are considered dead/dangerous and require emergency works.

The Council confirms that the remedial works as described above are exempt from the need for further notifications or any formal application to the Council and you are therefore allowed to proceed.

Informative(s):

- 1 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 2 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works. For

Conditions and Reasons:

- 1 Between the November and March following the completion of works 2x golden rain trees (*Koelreuteria paniculata*) with a circumference of 12-14cm at 1m above the base of the stem shall be planted within 2m of the location of the application trees unless otherwise agreed with the council in writing. The trees shall be planted and maintained in accordance with BS8545:2014.

Reason: In order to comply with s.206 of the Town and Country Planning Act 1990 (as amended).
