Proposal:
(TPO REF: C1293 2023) NORTH SIDE OF STREET: 4 x Oaks (G1) - Prune growth overhanging roadside to south back by around 1m in line with kerb, up to a height of 4m, pruning to suitable growth points/branch fork junctions. Prune north side of crowns back by around 1m to maintain balance and reasonable form to maintain clearance from bus route.
8 x Oaks (T153-160) - Prune growth overhanging roadside to south back by around 1m (in line with kerb), up to a height of 4m, pruning to suitable growth points/branch fork junctions to maintain clearance from bus route.

The Council has considered your application dated 18 September 2024 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
