Sycamore at rear of garden: This tree is in a dangerous state after 2 major limbs failed over short period. Tree is covered in ivy but signs decay visible at the wounds of failed limbs. Remaining stem grows out at and angle adjacent to point of decay and previously failed limbs. Recommended work: Reduce overall tree to approximately 5 metres height and maintain as pollard to ensure structural stability.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
