Amendments Summary

- Revised description of development: Replacement of front boundary wall, replacement of door with window to front elevation, erection of bike and bin store with hard and soft landscaping.
- Drawings now have drawing numbers.
- Elevations now provided showing the proposed window with and without the front wall and in the context of the proposed bike and bin store
- Elevations shown of the bike and bin stores showing materials including the introduction of sedum green roof to the bike and bin stores
- Window section details now provided
- Boundary wall height. Detail of this is presented in the design and access statement in pages 7-10. There are 15 properties identified on the street that follow the pattern we are proposing. The taller boundary wall which obscures the bike and bin stores is more consistent with the existing street elevation.
- Bike and Bin stores are now shown on all elevations and sections for the proposed works
