- 1 x Ornamental Pear (T4) Crown reduce back to previous points, (approx. 1m height and 0.5m spread).
- 1 x Holm Oak (T5) Crown reduce height and spread by 25%, (approx. 3m height and 1.5m spread).

FRONT SIDE GARDEN: 1 x Ornamental Pear (T6) - Crown reduce back to previous points, (approx. 1m height and 0.5m spread).

- 1 x Cockspur Thorn (T7) Crown reduce height and spread by 25%, (approx. 1.5m height and 0.8m spread) to balance and shape.
- 1 x Cockspur Thorn (T8) Crown reduce height and spread by 25%, (approx. 1.5m height and 0.8m spread) to balance and shape.

REAR GARDEN: 1 x Birch (T22) - Fell to ground level and grind out stump.
