Description

No 39 Theobald's Road is a mid terrace building within the Bloomsbury Conservation Area. There are two properties in the building. One is a business premises called Rosanna Shaw Health and Beauty, which occupies much of the ground floor, and all of the basement. The second is our flat, which has its own entrance and hallway on the ground floor, and occupies additionally all of the first floor, all of the second floor and all of the third floor of the building. The roof of the building is above the third floor, therefore above our flat, and accessible only from within our flat. Part of the roof is a skylight, which provides light to the stairs between the second floor and the third floor of our flat, and also provides access via a ladder (which can be drawn down from the ceiling of the stairs) to the roof for the purpose of repairs to the roof, and in addition is a potential fire escape - if a person strong enough to lift the skylight was trapped on the third floor because a fire prohibited using the stairs to escape the building, then they could potentially open the heavy skylight and get out onto the roof, and also potentially onto the rooves of adjacent buildings. The current skylight is very old, probably Late Victorian. It has heavy lead sheeting all around it, which makes it extremely heavy to open - only a strong adult could open it. It also often leaks, especially in the heavy rains which have in recent years become the norm in London, which has resulted in much water leaking into the property, potentially doing lasting damage to the building. The current window is made of single glazed glass with a wooden frame with heavy lead sheeting around it. We wish to replace it with a wooden Velux modern window, which would fit into an aluminium flashing. The proposed new window would still allow access to the roof, but would be better sealed against incoming rainwater (Velux would guarantee that it is waterproof). It would also be much, much easier to open, as it would not require the lead sheeting around it. In addition, it would be double glazed, so provide better insulation for the building. The skylight is not visible at all from the street on either side - either from Theobald's Road on one side of the building, or from Lamb's Conduit Passage on the other side of the building. There is no danger of a young child accessing the roof because of it - the reason is that to lift down the ladder for access requires someone at lease five foot in height. The Freeholder of our flat is Camden Council, and we have already consulted them. After thorough consultation, they have given their permission for us to go ahead, subject to certain conditions, all of which we will comply with. In summary the proposal is to fit a new wooden skylight, double glazed for better insulation to the building, top-hung and therefore still allowing access to the roof for repairs and also as a potential fire escape.
