## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Proposal to fell a bay tree (Laurus Nobilis) at the rear of the garden of 12 Grove Terrace NW51PH.

This tree (#1 on attached sketch) self-seeded many years ago and co-exists with other considerably taller trees in a densely wooded area of the rear garden, near the property's mews garage. The stem of the bay grows very close to the 18th century brick garden wall we share with our neighbour's at no.11 Grove Terrace. Our neighbours have often expressed concern that the tree is undermining the stability of this wall and we agree with them – if it is not removed, this historic wall is in danger of collapse. The bay tree is also hindering the growth of other larger trees around it. If it were removed these trees would be given more space to thrive. We have contacted an arborist and he concurs with the above points.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
