having been historically managed at around 12-14m. Work is to return canopy size to a more manageable and suitable size for constrained location. Tree is also placing pressure on rear retaining wall
BS.N1 - Sycamore - 2-3m canopy reduction & deadwood. REASON: Management of canopy size to one that is more suitable for constrained
