# Identification of Tree(s) and Description of Works

T1 - beech tree (15m) located in 23 Church Row- - reduce height by approximately 2m and reduce lateral branches by approximately 1m, remove low snapped branch stub and lift crown by approximately 2m to balance crown.

BEECH TREE bordering 23 Church Row and 24 Perrin's Walk

The relevant estimated figures for this semi-mature beech tree are as follows: - current height of 15 metres; - distance from the trunk to the nearby houses of 6 metres. Please see attached photographs

#### Application

T1 - beech tree (15m) located in 23 Church Row- - reduce height by approximately 2m and reduce lateral branches by approximately 1m, remove low snapped branch stub and lift crown by approximately 2m to balance crown.

#### Subsidence

There is a significant risk of subsidence damage to 24 Perrin's Walk, a listed property. Given that the house is over 200 years old, any foundations are unlikely to be deep. The site has a Class D Shrink Swell hazard, according to the British Geological Survey. The tree is already causing damage to the boundary wall bordering the gardens of 23 Church Row and the garden of 24 Perrin's Walk.

#### Danger to occupants of nearby houses

This large tree is very close to the nearby houses (24 & 23 Perrin's Walk), and is leaning towards 24 Perrin's Walk. As a semi-mature beech tree it continues to grow and could double in size. Given the proximity and the angle of growth, in extreme weather the tree may fall onto the houses. The tree's unchecked growth is a danger to those living nearby.

To inhibit the root growth and risk of subsidence, and also to reduce the "sail area" and weight of the tree which threatens to topple over in extreme weather, we apply to crown the tree. William Amos

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
