T1: Horse chestnut (20m): Crown reduce by 4m due to decay at the base of the trunk, to keep tree at a size suitable for its location and as
part of regular maintenance.
T2: Eucalyptus (12m): Re-pollard to previous points removing 3m of growth to keep tree at a size suitable for its location and as part of regular maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

T5: Hawthorn (8m) Dieback: Fell

T3: Gleditsia (7m): Crown reduce by 2m to keep tree at a size suitable for its location and as part of regular maintenance.

T4: Apple (6m): Crown reduce by 1m to keep tree at a size suitable for its location and as part of regular maintenance.
