CW04	Curtain Wall	Ground Floor: First Floor, Flat 6; Master bedroom Second Floor, Flat 8; Ensuite	Fixed curtain wall	P.548	On the northwest elevation (CW04) the windows look out onto the flank elevations of buildings on the Kingsland Estate, which do not feature windows. Windows at first floor (at approximately the same ground level of the pavement on the Kingsland Estate) will be partly obscured by existing planting and boundary treatments.
					In combination these factors will prevent any infringement of privacy.
