There are no similar-sized outbuildings recently approved or existing in the immediate area, and approval would set a harmful precedent, potentially eroding the open green space pattern. The outbuilding's scale and inclusion of a kitchen and WC make it appear as a minor dwelling rather than an ancillary garden structure.
We have taken this advice into account, and the proposed outbuilding in this application is of significantly smaller dimensions, without a bathroom or kitchen. The proposed garden outbuilding would be used as a gym or a home office for a purpose incidental to the enjoyment of the ground floor flat.
