Rear Garden: T1&T2: 2 x Mature Leyland Cypress: Approximately 8.00m: Reduce back to previous and most recent reduction points approximately 2.00m height and 1.50m lateral and sub lateral spread. To ensure branch sustainability. T3: Mature Maple: Approximately 6.00m: Reduce crown by up to 1.20m. Thin crown density throughout by 20%. General maintenance. Rear Boundary: G1: Group of Leyland cypress Approximately 8.00m: (Rebind shed): Reduce lateral and sub-lateral growth back as is

maintenance.

T5: Mature bay: Approximately 7.00m: Reduce height back to previous and most recent reduction points approximately 2.00m. Reduce lateral

T4: Mature Sycamore: Approximately 15.00m: Reduce back to previous and most recent reduction points approximately 2.20m. General

practicable approximately 1.25m. Reduce height by approximately 1.50m-1.70m. General maintenance.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
