Horse chestnut (T2) - reduce crown by 1m back to previous cuts. To let more light on to the green roof beneath the tree

Sycamore (T3) - reduce crown back to previous cuts (2m off). To let more light on to the green roof beneath the tree

Horse chestnut (T4) - reduce crown back to previous cuts (2m off). To let more light on to the green roof beneath the tree.
