Red oak (T1) - Fell tree. There is extensive dieback in the crown. Use of sounding mallet indicates decay is widespread in the base of the tree. There is visible decay at the base of the tree on the south side, extending around to the west, and visible on the north. An 18" probe can be inserted fully into the base of the tree. Replant with one red oak 10-12cm girth.
Holly (T2) - Fell. The tree is colonised with Kretzschmaria deusta around the base. Tree is liable to fail in high wind.
