Proposal: Display of 2 x externally illuminated fascia signs. Drawing Nos: Location plan; Issue No. 01; Issue No. 02.

The Council has considered your application and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

1 No advertisement is to be displayed without the permission of the owner of the site or any other person with an interest in the site entitled to grant permission.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

2 No advertisement shall be sited or displayed so as to

(a) endanger persons using any highway, railway, waterway, dock, harbour or aerodrome (civil or military);

(b) obscure, or hinder the ready interpretation of any traffic sign, railway signal or aid to navigation by water or air; or

(c) hinder the operation of any device used for the purpose of security or

surveillance or for measuring the speed of any vehicle

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

3 Any advertisement displayed and any site used for the display of advertisements, shall be maintained in a condition that does not impair the visual amenity of the site.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

4 Any structure or hoarding erected or used principally for the purpose of displaying advertisements shall be maintained in a safe condition.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

5 Where an advertisement is required under these Regulations to be removed, the site shall be left in a condition that does not endanger the public or impair visual amenity.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

Informative(s):

1 Reasons for granting consent:

This application seeks consent for the display of two externally illuminated fascia sign, fronting High Holborn and Gray's Inn Road respectively.

The proposed fascia signages would be approximately 7900mm x 1035mm x 60mm and 18700mm x 1035mm x 60mm. Both signages will be made with folded powder coated aluminium pan with white acrylic letters and green graphic in vinyl. Only the letters of the shop name "Robert Dyas" on the two proposed fascia signages will be externally illuminated by a static trough light in white colour with an illuminance level of 120cd/m2. Overall, the proposed signages are considered acceptable in terms of size, material, number, illuminance level and position. As such it is considered there would be minimal visual impact resulting from the proposal.

The proposed advertisement letters would not impact on amenity in terms of light spill or outlook, nor would it be harmful to either pedestrian or vehicular safety.

The application site's planning history was taken into account when coming to this decision.

As such, the proposed development is in general accordance with Policies A1 and D4 of the Camden Local Plan 2017, the London Plan 2021, and the National Planning Policy Framework 2023 and CPG Advertisements 2018.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2021.
