LOWER GROUND FLOOR NOTES:

Dining Room
Non-original plasterboard ceiling with down lights and no cornicing. Ceiling to remain as is and down lights to be replaced with pendant and wall lights.

2. Hallway

Non-original plasterboard ceiling with down lights and no cornicing. Ceiling to remain as is. Fuse box to be removed from ceiling and relocated to storage cupboard. Down lights to be replaced with pendant and wall lights.

3. Kitchen

Non-original plasterboard ceiling with down lights and no cornicing. Ceiling to remain as is. Down lights to be replaced with newer and more energy efficient equivalent.

4. WC/Study Non-original plasterboard ceiling with down lights and no cornicing. Ceiling to be reinstated where non-original internal partitions have been removed. New pendant lights to replace existing down lights.

5. Utility Room

Non-original plasterboard ceiling with down lights and no cornicing. Down lights to be replaced with newer and more energy efficient equivalent.





GROUND FLOOR NOTES:

 Living Room & Sitting Room
Carefully remove the non-original plaster boarding to expose the original lath and plaster ceilings. Repair the original lath and plaster ceiling where possible by a specialist; if the lath and plaster ceilings are found to be beyond repair, replace with new lath and plaster ceiling b a specialist. Repair and make good original cornicing. If the cornicing is beyond repair, replace with new to match original. Replace non-original ceiling roses with new period-appropriate designs. Remove existing down lights, make good ceiling and replace with pendant and wall lights.

2. Entry Hall

Non-original plasterboard ceiling to remain in place. Non-original cornice to be replaced by new more appropriate cornice. Down lights to be replaced with pendant light.

3. WC

Non-original plasterboard ceiling with down lights and no cornicing. Ceiling and lighting to remain as is. Down lights to be replaced with newer and more energy efficient equivalent. .

4. Office/Powder Room

Non-original plasterboard sloped ceiling with down lights and no cornicing. Ceiling to remain as is. Down lights to be replaced with newer and more energy efficient equivalent.







