Tree location - front and rear garden

Access - side access

T1 - Approx. H17 S8 30+DBH Liquidambar

Selectively crown reduce height by 2m. Reduce laterals by 2m to form a neater balanced symmetrical shaped canopy.

T2 - Approx. H5 S5 20DBH Magnolia

Crown reduce height and sides by 0.5-1m (regrowth). Thin 15%

GRP1 - Mixed trees in adjacent garden

Cut back encroachment to boundary line (regrowth)

T4 - Approx. H5 S4 20DBH Pittosporum

Crown reduce height and sides by 0.5m (regrowth)

T5 - Dead - Pineapple tree

Fell & remove

T6 - Approx. H8 S4 20DBH Hazel

Remove basal growth

T7 - Approx. H1 S1 20DBH Hazel

Coppice regrowth. Reduce laterals that extends across rear garden by

0.5-1m

  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
