FRONT GARDEN: 1 x Hawthorn (T3) - Fell to ground level.  
1 x Kohuhu (T9) - Fell to ground level.  
REAR GARDEN: 1 x Lime (T5) - Lift canopy to height of 3m.  
1 x Kohuhu (T7) - Fell to ground level.  
1 x Midland Hawthorn (T10) - Fell to ground level.  
1 x Hybrid Black Poplar (T11) - Fell to ground level.  
1 x Hybrid Black Poplar (T12) - Reduce height of canopy to previous pollard points at a height of approx. 8m - 9m.  
1 x Hybrid Black Poplar (T13) - Fell to ground level.  
1 x Hybrid Black Poplar (T14) - Fell to ground level.  
1 x Hybrid Black Poplar (T15) - Reduce height of canopy to previous pollard points at a height of approx. 8m - 9m.  
1 x Hazel (T16) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 13 September 2024 and does not wish to object.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
