T2 Robinia front right Neighbour tree on front left, reduce and reshape by approx. 3m.
T3 Robinia front right Adjacent to T2, leaning. Fell to ground level.
T5 Lime x6 rear right Pleached trees. Reduce back to previous reduction points. T7 Yew Laurel rear right Reduce and reshape by 30% or 2m.
T8 Ash rear right hand corner Extensive die back in upper crown. Fell to ground level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

T9 Bay rear left Trim to shape by 1m.
