T1) Apple: Reduce height by up to 2 metres; lightly reduce width by up to 1 metre; maintain natural and even flowing canopy outline; remove crossing branches and any dead and defective branchwood.
T2) Mature Sycamore: Reduce lateral spread over garden by up to 2.5 metres to provide more light into garden; maintain natural and even flowing canopy outline.

T3) Norway Maple at rear of garden: Reduce overall crown by up to 3 metre branch lengths to provide light into garden; maintain natural and

even flowing canopy outline; remove any dead and defective branchwood.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
