T1- Pyrocanthus- (4m)- prune by 50cm.
T2-Yew tree- (4m)- very light hedge trim of up to 30cm on all sides including back of hedge, reduce height by approximately 6 inches,
T3- Weeping Birch tree-(7m)- prune in any long branches protruding out of top of crown by up to 1.5m, lift crown by approximately 50cm.
