Given the existing detached rear garden building on the site, the principal of replacing it is acceptable.
The proposed height should be lowered by half a metre (500mm).
The building should also be set back from the boundaries like the current building.
Repair works to the boundary walls should be in matching materials and brick bond.
Significant trees on site and on neighbouring sites should influence design, and be protected and retained.
You should provide a biodiverse roof on the structure and provide the details of the roof system showing a minimum substrate of 100mm.
Setting back the structure from the boundaries is likely to improve the relationship to the neighbouring properties.
The glazing should be reduced in area to avoid excessive lights spill from the structure.

Each of the above comments has been reviewed by the Client and design team and have been addressed within the revised design.
