T1: Mulberry: Approximately 5.50m: Reduce crown height by approximately 1.20m. Reduce lateral growth by up to approximately 1.50m to help produce and promote a more compact crown structure. Raise crown by approximately 0.70m. Thin crown density throughout by
approximately 20%. General maintenance. T2: Magnolia Grandiflora: Approximately 6.00m: Reduce over extended branches back into the main crown structure approximately 1.20m.
