T1 - Lime - reduce crown to points of previous reduction (3-4m height reduction, 1-2 from lateral growth. Crown lift to 7-8m from ground level (epicormic growth). This is routine maintenance of a large tree in close proximity to the building and overhanging the public highway

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
