Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - magnolia tree (4m) - reduce crown to previous pruning points, approximately 2m reduction and remove shoots from base of tree.

T2 - birch tree (12m) -cut to ground level.

My reasons for wanting the tree removed are as follows:

1. The silver birch roots are causing dramatic upheaval of the ground along the entire end of the garden - breaking the wall of the canal, destabilising the foundations of the summer house, and cracking the wall to the next-door garden.
2. The tree itself now casts thick shadow over my neighbour's garden (no. 8 St Mark's Crescent) causing them great annoyance.
3. The need to prune the tree in itself reduces its beauty and thus its benefit to passers-by on the canal towpath.

I realise all this is caused by my ignorance in mistakenly planting the tree there in the first place, but now I feel the serious damage it causes to me & my neighbours outweighs any public benefit it provides. And I would undertake to plant another more suitable tree as a replacement.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
