SIDE GARDEN: 1 x London Plane (platanus x hispanica) (T1) - Re-pollard back to previous pruning points by removing approx. 4m - 5m from height and 2m - 3m lateral growth, to include removal of all epicormic and basal growth.

REAR GARDEN: 1 x London Plane (platanus x hispanica) (T2) - Re-pollard back to previous pruning points by removing approx. 3m - 4m from height and 4m - 5m lateral growth, to include removal of all epicormic and basal growth.

1 x Tree of Heaven (Ailanthus altissima) (T3) - Re-pollard back to previous pruning points by removing approx. 4m - 6m from height and 2m - 3m lateral growth, to include removal of all epicormic and basal growth.

Group of Tree of Heaven (Ailanthus altissima) (G3) - Re-Coppice group at ground level.

FRONT GARDEN: 3 x Birch (Betula ssp)(G8) - Fell as close to ground level as possible and leave the stumps in the ground.

- $2\ x$ Rowan (Sorbus aucuparia) (G9) Fell as close to ground level as possible and leave the stumps in the ground.
- 1 x Birch (Betula pendula) (T11) Prune to give around 1m clearance from pedestrian crossing lights.

The Council has considered your notification of intended works to trees dated 18 September 2024 and does not wish to object.
