T1 London plane tree- Large cavity a base with heavy lean to wards drive way of 17-19 Lyndhurts terrace, client has been advised by Camden council to remove this tree as one has already fallen over next to this tree (client not advised by us)

T2- Large sycamore located back garden, overhangs public footpath and touching neighbouring property, client would like to reduce height and spread 3-5m all round to make it easier to maintain considering the location.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o adding other relevant features on the site (e.g. greenhouse, paths)
