## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1. Laurus nobilis: the tree is multi-stemmed, with four main stems. Two of the stems are growing right up against the party wall which is causing flood damage through the wall to the to the neighbouring property. We plan to engage a tree surgeon to remove these two stems at the base, leaving the remaining two stems which are growing safely away from the wall. The remaining stems are also further away from the glass conservatory which is being replaced. We also plan to reduce the height of the canopy by up to 2 meters to allow more light into the house.

T2. Acer negundo: This tree is extremely fast growing so we plan to engage a tree surgeon to pollard the tree in way which reduces the height of the canopy by up to 3 meters and encourages bushy growth lower down.

Neighbours at no. 38 Downshire Hill who will be affected by the proposed works have been informed of the plans and are a very happy for the works to go ahead.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
