T1 Willow x 1 (Salix spp) A great specimen of a mature historically pollarded tree, that needs maintenance as regrowth is becoming too large for
older limbs and to slow root expansion and to improve access for pedestrians and traffic. Suggested works:

- Reduce all round to previous reduction points approx. 4-6m

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- Leaving shortened pendulous furnishing growth
