Reason for works: Regular tree maintenance and the trees are causing significant damage to the driveway.

Please find attached the report received from the insurers regarding damage caused by the tree on the tarmac at 10 Langland Gardens.

Whilst the report advises there is no subsidence, it clearly indicates that any remedial works to the tarmac will be fruitless as the roots will continue to destroy whatever they put down.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
