Oak (T1) - Reduce branches overhanging the roof of 9 Robin Grove by 2.5m. Reduce one long over extended hanging limb over the garden of 9 Robin Grove by 2.5m. To provide clearance from the roof and the garden, it is hanging right over.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
