Proposed Work:  
REAR GARDEN: 1 x Dead Tree (T1) - Fell to ground level.  
1 x Eucalyptus spp (T2) - Reduce in height approx. 5m and reduce laterally by up to 2m to shape.  
1 x Magnolia (Magnolia spp) (T3) - Reduce all round by approx. 1m to shape.

The Council has considered your notification of intended works to trees dated 27 September 2024 and does not wish to object.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
