Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Leyland Cypress - The lateral reduction of 2m on the property side of T1, the lifting of low growth to 2m from ground level of the public highway, the overall lateral and apical reduction of 1m not beyond evident green points of growth. Management should be implemented no less frequently than once every three years.

Reason - T1 is within the NHBC 4.2 area of influence of multiple properties.

6.1 - T1 is within the NHBC 4.2 area of influence of multiple properties.

6.2 - There is a camber dip to the driveway between T1 and the damaged area of the bay window.

6.3 - There is cracking to the bay window at the closest area to T1. The step cracking points towards the tree. Dr Martin Dobson suggests that there is a high association between tree related subsidence when step cracking points to a tree in the area of influence.

6.4 - This site is situated on a clay bedrock.

6.5 - The industry recognised management for property damages that have a potential association with tree related vegetative water extraction, is to reduce crown volume.

6.6 - Reduction leaf cover will result in a reduced evapo-transpiration potential (ETP), ETP has direct correlation with vegetative associated subsidence.

6.7 - The industry recognised way of managing trees that have a proven association with property damages, when crown reduction works does not settle those damages, is to remove the tree.

6.8 - In accordance with The Occupiers Liability Act 1984 (SECTION 5) reasonable measures must be undertaken to ensure that a tree does not have a negative impact upon neighbouring land.

6.9 - T1 lateral growth is 0.5m from the adjacent structure

6.10 - Low growth from T1 is below 1.5m over the public highway

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
