Work Required - Re-pollard back to previous pruning points by removing approximately 3.5m regrowth. Sever and clear a 1m section of lvy from the circumference of the stem.

Reason - As part of regular cyclical maintenance, to maintain clearance from neighbours building, to reduce encroachment of Ivy into crown.

Priority Code - B
