London plane (T1) - Re-pollard back to previous most recent pollard points.
Leylandii hedge (G2) - Reduce height by 2 feet and trim to front to square it off
Magnolia (T2) - Reduce crown by 2m on all aspects.
Honey locust (T3) - Reduce crown by 1.5m on all aspects. All the work is to restrict root growth and let more light into the property
