I would like to remove a cabbage palm tree from my garden and whilst it is not the subject of a TPO I understand that due to the fact that the property is in a conservation area and the tree is over 10 cms in diameter and over 1.5 metres tall, I am obliged to seek your consent before it is removed.

I have attached a plan of the lower ground floor of flat 2, 12 Lyndhurst gardens along with a photo of the tree that I am asking to remove.

The palm tree was planted just over 24 years ago by the former occupant of our apartment. It now towers over a South Australian fern that is next to it. We are in the process of renovating and extending our apartment and this cabbage palm is now very close to the new extension.

The tree is not an indigenous plant to the UK and due to the height of the plant it now obscures both sunlight and the view from the ground floor bedroom in the apartment as well as from other neighbouring properties. We already have two substantial trees in the back garden both of which are subject to TPOs and other smaller trees none of which we are applying to be removed. We propose to plant a Ceanothus tree in the place of the cabbage palm which will not grow to the same height but which will provide greater colour and interest into the garden and the local area.

We would like to remove the tree as soon as possible but i understand that you have 6 weeks to respond to our application.

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

I would like to cut down a cabbage palm tree from the rear garden of flat 2, 12 Lyndhurst gardens. This tree is located by a red mark on the plan I have attached. The photo shows the cabbage palm and to the right handside of the tree you can see a fence - this fence marks the boundary between our garden and the garden of the flat 1, 12 Lyndhurst gardens. This is approximately 8 feet from the tree. The boundary of the garden with that of 14 Lyndhurst gardens is shown on the second plan I have attached. The tree is approximately 8 meters from the boundary with that of 14 Lyndhurst gardens.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
