T1- Cherry staring to encroach over Maresfield road. we would like to prune the tree back from the road. to give 3-4m clearance. removing approx 2-3m

T2- Lime tree, tree is starting to affect the boundary wall with clear cracking, we would like to re-pollard back to previous points, inline with historic pruning.

T3- Ailanthus, Tree of heaven previously reduced, we would like reduce 1-2m all round reduction and deadwood. growing close to property we would like to give 2-3m clearance and balance crown

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - · showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
